PENNSYLVANIA'S RESPONSE TO MONEYGRAM PAYMENT SYSTEM INC.'S CROSS-MOTION FOR AN ORDER DIRECTING PARTIAL RELEASE OF DEPOSITED FUNDS

Pennsylvania does not oppose MoneyGram Payment System Inc.'s Cross-Motion for an Order Directing Partial Release of Deposited Funds. MoneyGram seeks reimbursement for \$184,532.01 for items originally purchased in Pennsylvania. *See* MoneyGram Br. at 7. MoneyGram's books and records reflect those abandoned items were deposited in the Court's registry and then were subsequently honored and paid by MoneyGram. *See* MoneyGram Br. at 4. Thus, the funds should be reimbursed to MoneyGram. Therefore, MoneyGram's Motion should be granted insofar as it concerns the above-referenced sums originating in Pennsylvania.¹

Since filing the Motion, however, Pennsylvania has identified a small calculation error regarding Official Checks from 2020, where an additional \$2540.01 should also be attributed to Pennsylvania (for a total of \$6,333,610.92). Thus, if the Court grants MoneyGram's Motion, the amount of the principal in the Court registry attributable to Pennsylvania will be **\$6,149,078.91**.
