## NOTICE TO THE PARTIES


PIERRE N. LEVAL, *Special Master*:



Administrative Office at equal to ten percent (10%) of the income earned for deduction in the investment so held and without further order of the Court.

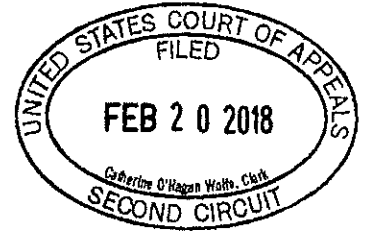
