STIPULATION


MoneyGram Payment Systems, Inc. (“MoneyGram”) agrees to be bound by any judgment of the United States Supreme Court in Original Action No. 22O145 or 22O146. MoneyGram agrees that it will cooperate with reasonable requests for discovery in the course of this litigation without the need for subpoenas. All parties agree that MoneyGram will not remit the proceeds from any unclaimed “Official Checks” to any state during the pendency of this lawsuit. MoneyGram will attempt to make arrangements to deposit the proceeds from current and future unclaimed “Official Checks” that have been unclaimed for five (5) years or more into the registry of the United States District Court for the Southern District of New York, or some other type of escrow fund on terms agreeable to all the parties if the Southern District of New York is unavailable for this purpose, on an annual basis.




